Moreover, the findings, with regard to the different fields of law in the Member States, are compared. On the basis of a thorough analysis of the status quo in the EU and Member States legal systems, recommendations have been developed, including suggestions on the possible improvements to the standing requirements in the EU and national legal systems.
