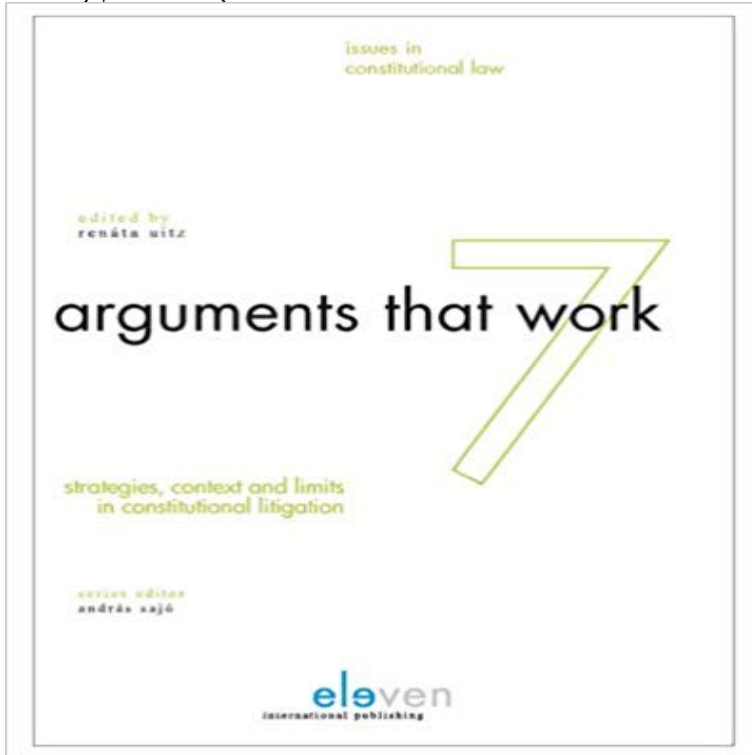


Arguments that Work: Strategies, Contexts and Limits in Constitutional Litigation (Issues in Constitutional Law)
