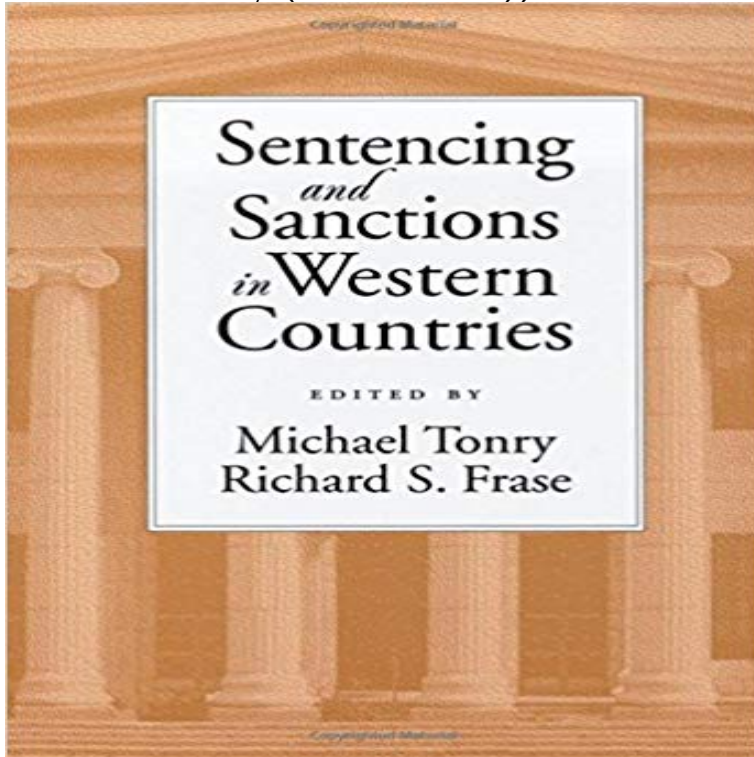


Sentencing and Sanctions in Western Countries (Studies in Crime and Public Policy (Hardcover))
