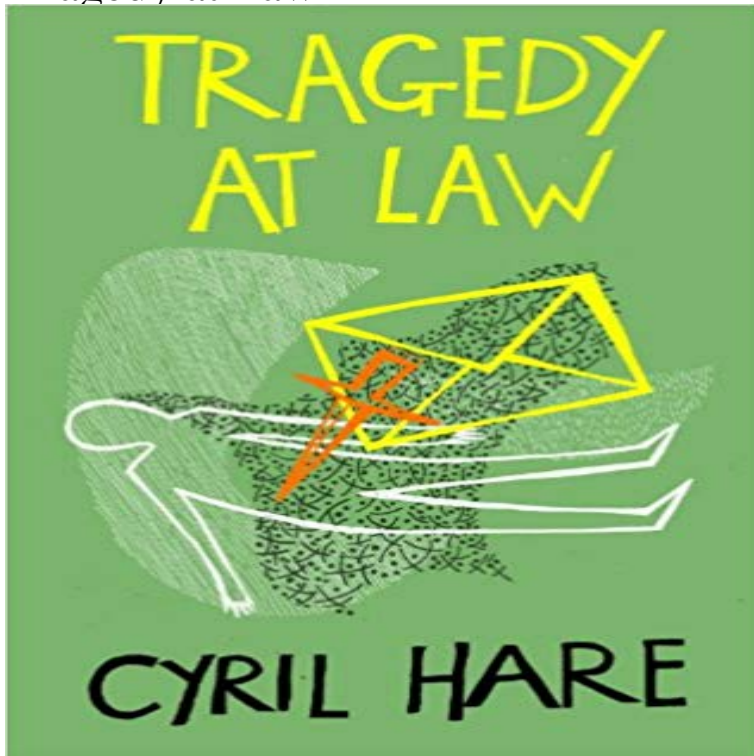


## Tragedy at Law
