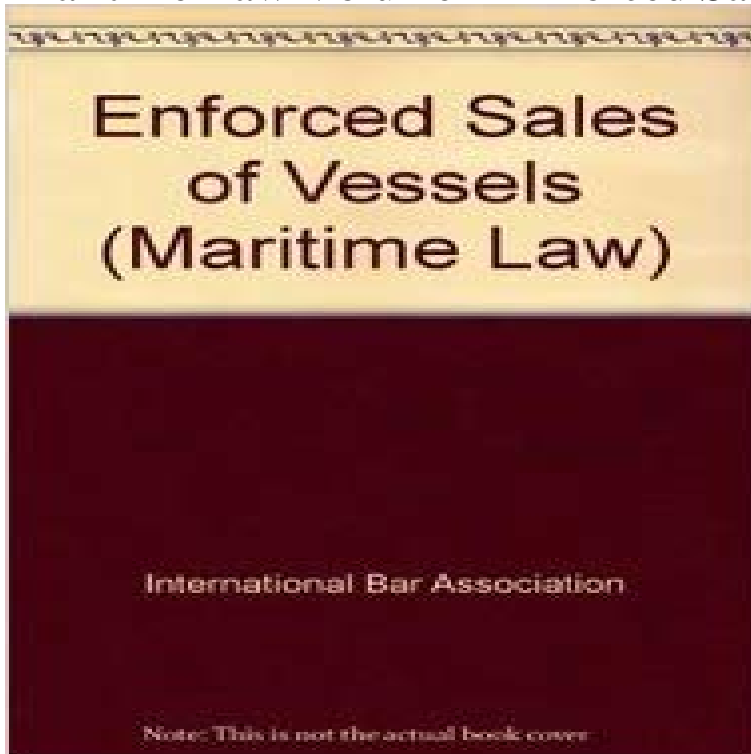


## Maritime Law Volume II Enforced Sales of Vessels
