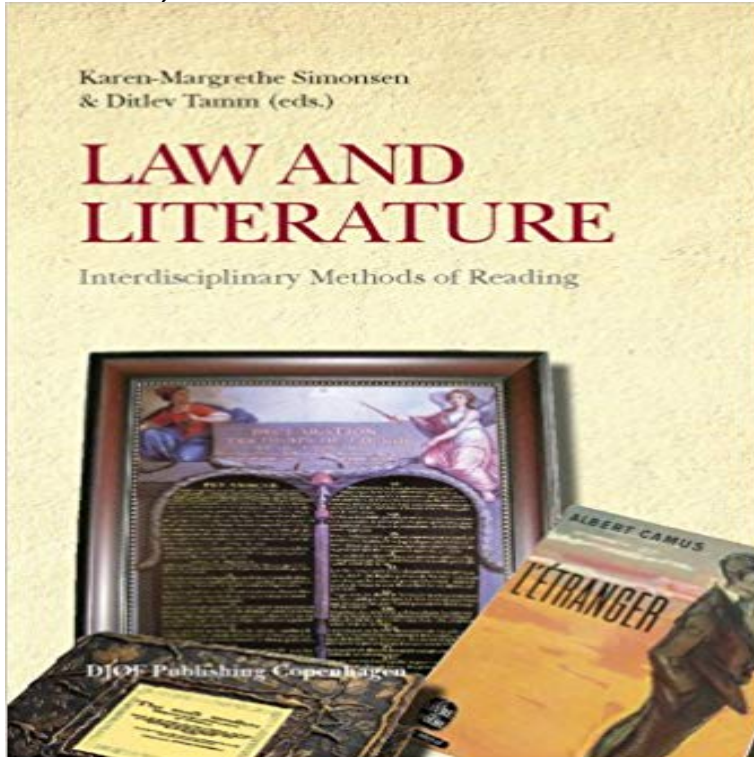


Law and Literature: Interdisciplinary Methods of Reading (Law and Culture)
