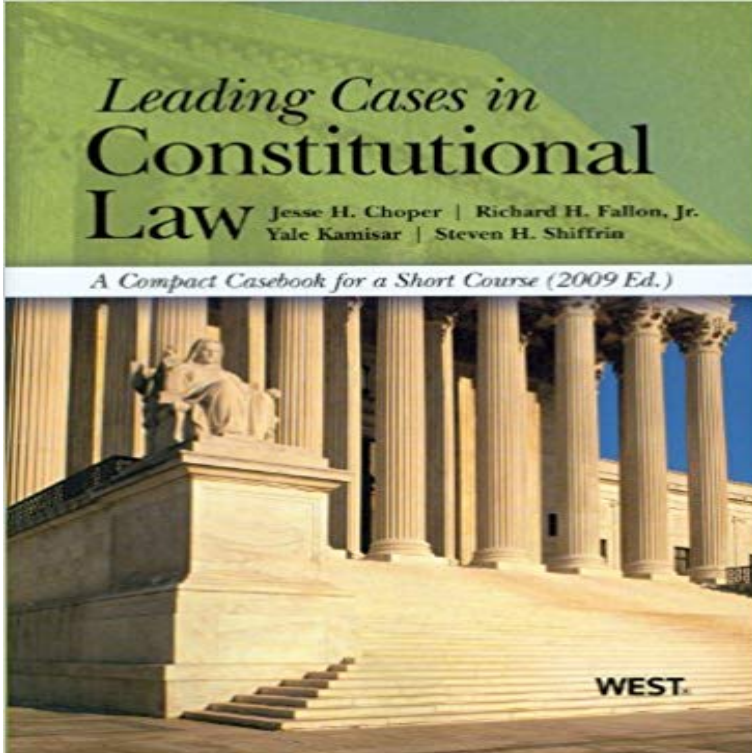


## Leading Cases in Constitutional Law, a Compact Casebook for a Short Course, 2009 Edition (American Casebooks)

The new paperback will be published every summer for classroom use in the fall. It will include all the significant cases handed down during the most recent Supreme Court Term. Leading Cases contain what one might call the essentials for teaching a basic course in constitutional law. The organization of the new compact book will be similar to the much larger Choper - Fallon - Kamisar - Shiffrin casebook (one which will continue to be revised and published) and the big book (which contains many Notes & Questions) will be available as a resource book for the smaller one.
