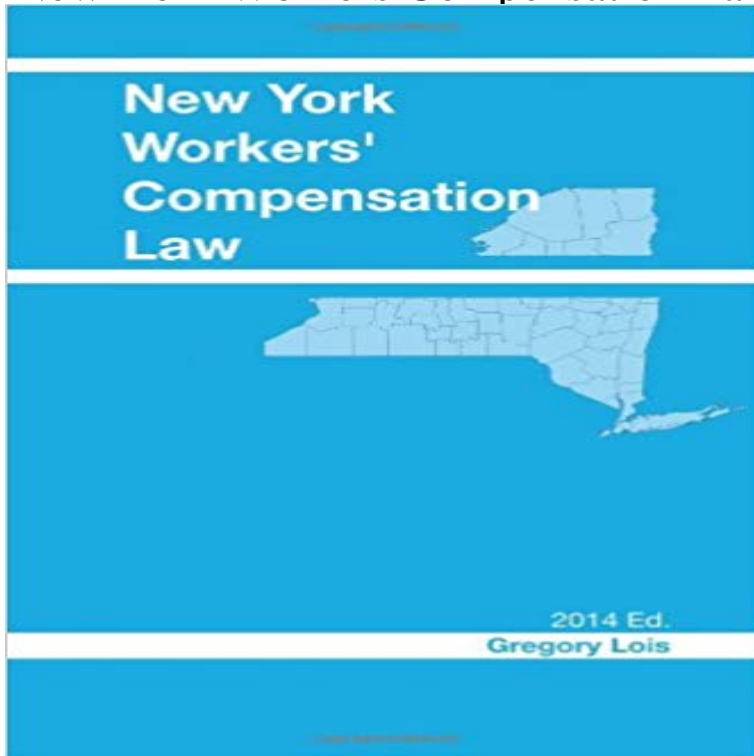


## New York Workers Compensation Law: 2014 Edition
