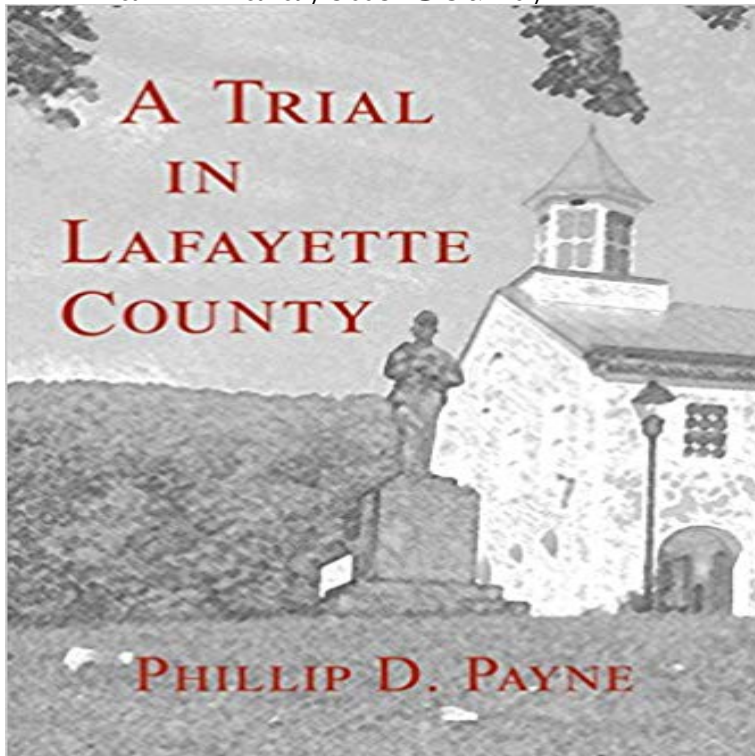


A Trial in Lafayette County
