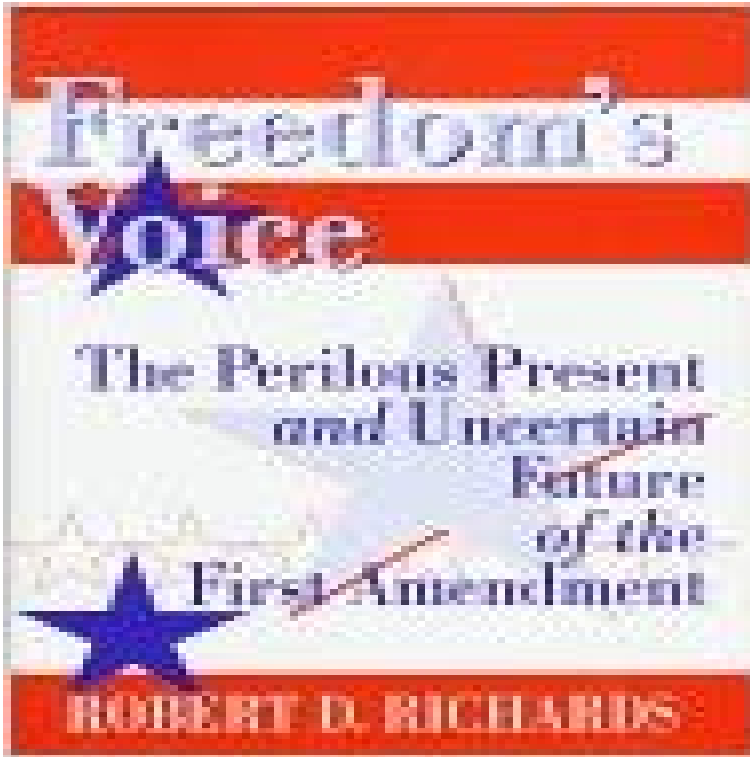


Freedoms Voice: The Perilous Present & Uncertain Future of the First Amendment
